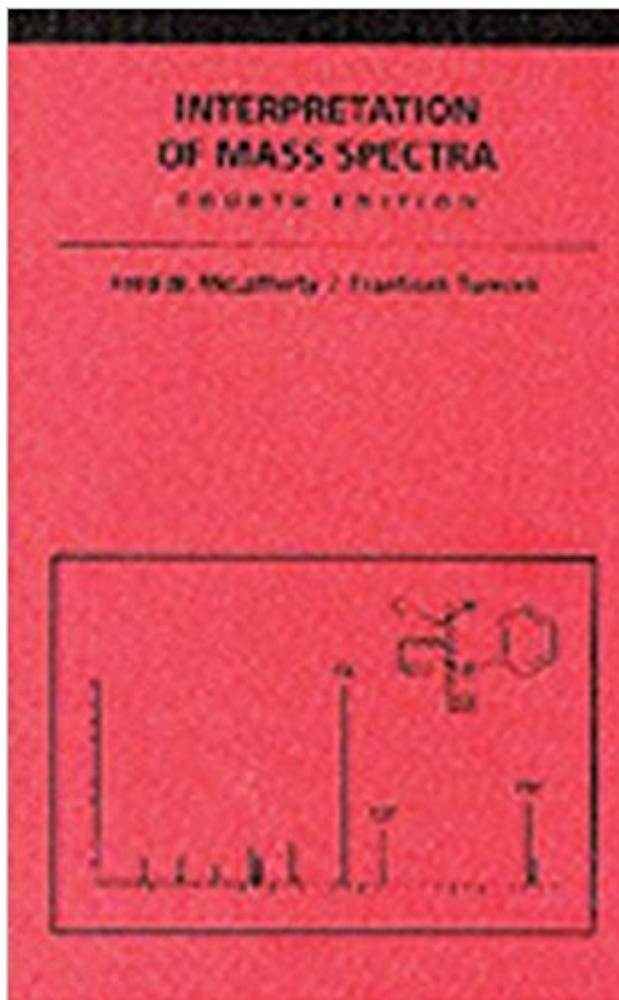

If you are starting to interpret EI mass spectra, this is the perfect guide to start with. It is concise, well-written, and very comprehensible. I only give it 4 stars because it should be understood that this is not a comprehensive guide to MS, it doesn't really cover ESI, MALDI, ORBITRAP...etc. If you are working with electron ionization (EI) or just starting to interpret your own spectra for low molecular weight species, this is your book. If you are trying to understand MS for high molecular weight proteins and such, I would recommend looking at Introduction to Mass Spectrometry by J. T. Watson.

I learned MS with this book more than 30 years ago. It explains mechanisms extremely well. One drawback is that this book does not have current techniques such as ESI, MALDI, etc. because this book is pretty old.
