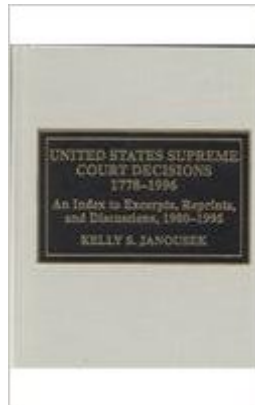

The volume is divided into five major parts: a bibliography of nearly 600 titles; a listing of over 300 periodical titles; a chronological list of the court decisions, each with a citation, a date, and a list of relevant secondary works; an alphabetical listing of parties involved in each case; and a subject index to the topics discussed in the various cases.
