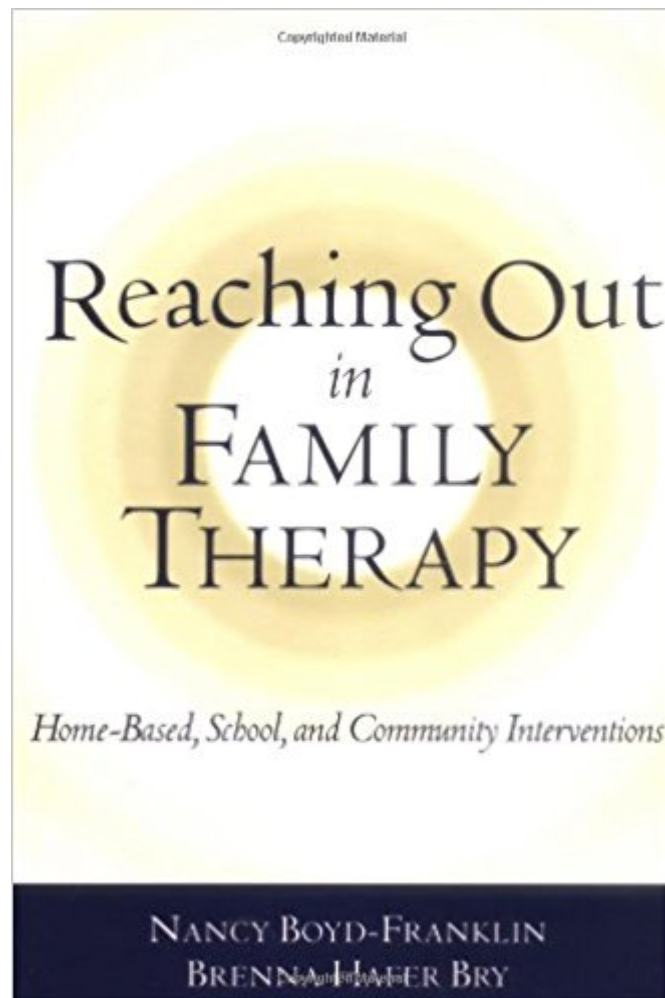

Reaching Out In Family Therapy: Home-Based, School, And Community Interventions



Synopsis

This volume provides the skills practitioners need to conduct family therapy sessions in the home, school, and community. The authors demonstrate how meetings outside of the traditional office setting can enable therapists to intervene actively in the various systems that affect clients' lives. This multisystems approach can be particularly useful when working with poor and ethnic minority families, whose support networks may include extended family, school personnel, and members of the "church family." Practitioners learn how to utilize out-of-office sessions to meet the people who are influential in clients' lives; observe the life realities of children, adolescents, and parents; and identify resources that can be mobilized to produce change. Detailed strategies are presented to help families navigate the overlapping demands of multiple agencies and institutions and to manage and prevent such problems as substance abuse, school drop-out, and child abuse. Throughout, therapeutic and ethical guidelines are illustrated by extensive clinical case material. The book is ideal for those already doing home-based work, as well as those who would like to incorporate it into their practice.

This was a required text for a practice class in social work. By the end of the quarter, we managed to convince the professor to stop using this book. Why? Well, it's probably one of the most racist texts I have read in my program. The irony is that the author is African American, yet she continues to perpetuate negative stereotypes toward African American clients. Whaaaaaat? It has to be read to be believed. The text was written in the early-2000s, which makes the content even more appalling. It is culturally insensitive, and, frankly, counterproductive to any social worker's or therapist's education. The author's definition of strengths-based therapy will blow your mind and does nothing to promote social justice. She basically advocates to maintain the status quo to continue treating minorities like second-class citizens, and to shrug off abuse (physical and mental) as just something that's culturally appropriate for African American families.

This book was a recommendation for social workers in graduate school. It is worth the cost and very insightful. The knowledge gained from the content will strengthen your abilities as a social worker.

I had to buy this book for a class but enjoyed it more than I thought I would. It is very informative and helpful for someone who is doing home-based family therapy.

In this tour de force, Boyd-Franklin and Bry present a wonderful working model for "home-based family therapy," which Madsen (2007) calls getting off "professional turf" and onto "family turf," leading to greater collaboration. Boyd-Franklin & Bry outline a three phase model, which has become the working model of our agency. The phases are: 1) the entire family, 2) an individual session with the "IP" (identified patient) or a sub-system, and 3) meet again with the entire family. While this is intensive on clinicians (2+ hours/per week/per family), after four months you can

terminate with a "vastly, vastly improved" client system. There's lots of good "evidence-based treatment" (EBT) research to back this up, but regrettably agencies look at the "real client" - \$\$\$ (the third-party payer) - and choose in his favor. So, if you're more interested in helping families than serving managed care or the government, this book is a good start. For its low price, you can't beat it!
