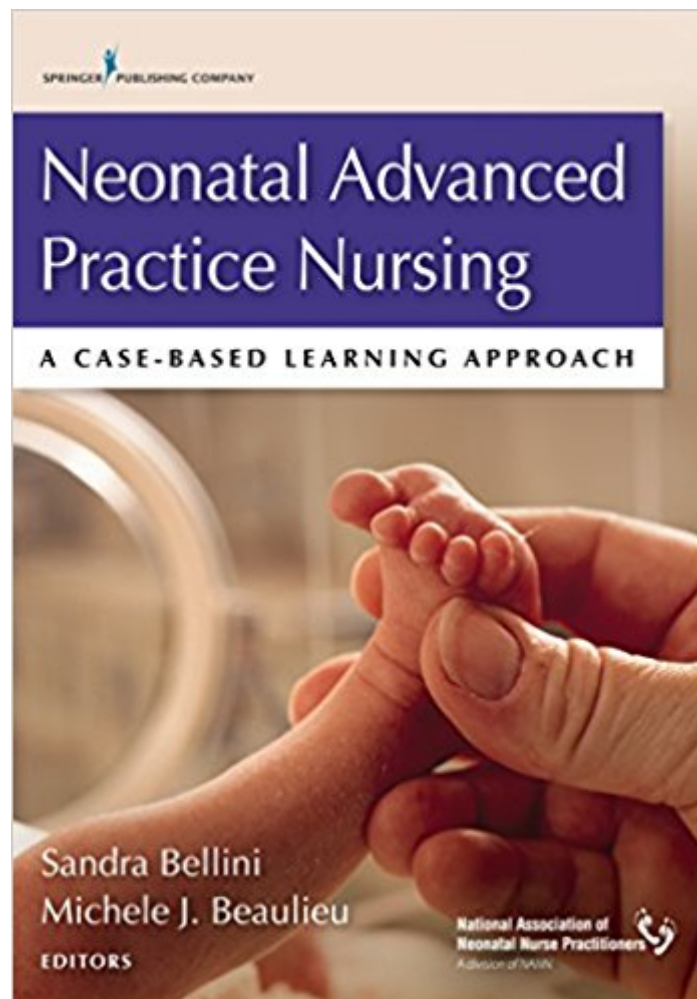

In addition to her full-time neonatal practice, Dr. Beaulieu has been the column editor for "Pointers in Practical Pharmacology" in Neonatal Network: The Journal of Neonatal Nursing, author and expert reviewer of various peer-reviewed manuscripts and books, and is the coinvestigator for several research studies. Her research interests include perinatal safety, extremely low-birth-weight infants, neonatal abstinence syndrome, and the management of high-risk newborns in the delivery room.
