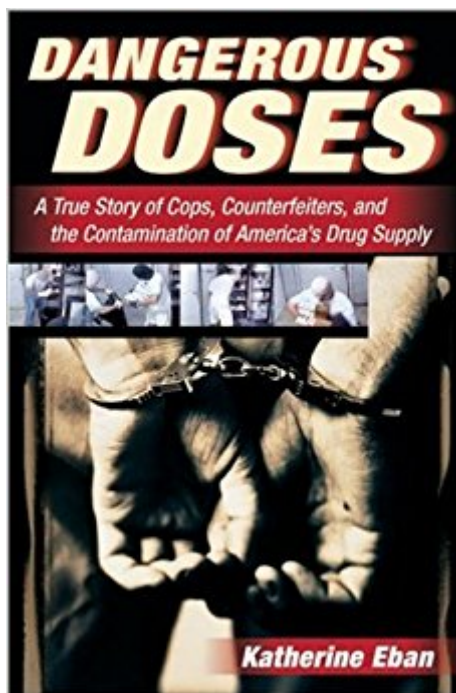

As a Director of Pharmacy, I strongly encourage DOPs working in specialty areas to read this. Things like the DSCSA work to prevent the entire premise of this book, but there are still concerns. I bet there are still some "good old boys" are still out there, trying to stack illegal cash....

This is a meticulous example of "American Greed" in the nation's drug supply. It details how a network of criminals have systematically penetrated the legitimate drug distribution system, putting thousands at risk. The thugs buy stolen drugs, relabel them as more costly versions, or co-mingle them with counterfeits - and reinsert them back into the drug distribution system of legitimate wholesalers and chain pharmacies. Not just Viagra - cancer drugs, drugs that maintain the clotting capabilities of dialysis patients - and more. The tragedy: Even when caught, the criminals do little or no jail time - and some are actually back in the businesses they were in when they committed their crimes!This is a great, great read!

This book left me with an awareness of how dangerous our own neighborhood pharmacy or hospital can be when they dispense pharmaceuticals to us. I will never see labels of trusted pharmaceutical companies the same after the awareness that this investigation brought. Most of us think that our

drugs come straight from the drug company to the pharmacy and are safely handled by all involved. This investigation will make you sick that there were so many victims of the middle distribution of our medications, and make you cheer for the brave protectors of our health.

If you weren't passionate about your work in pharmaceutical brand protection, you will be after reading Katherine Eban's ground breaking book. Having been professionally involved with "compliance" activities to meet California and global requirements for pharmaceutical serialization and product authentication since 2007, this recent read has ignited a true purpose for me in my current career path. It reads like a good mystery novel, but the shocking reality of the actual criminal activities that impact human health brings this story close to the heart.
